

# Tracy V. Maitland to Receive Honorary Degree from Virginia Union University and Establish Endowed Scholarship

NEW YORK, 05.12.2023 - The Virginia Union University Board of Trustees has announced that Tracy V. Maitland will be receiving an honorary Doctorate of Humane Letters during this year's commencement ceremony on May 13th. Mr. Maitland, the President and Chief Investment Officer of Advent Capital Management, has been selected in recognition of his outstanding contributions to the fields of finance and philanthropy.

Virginia Union University was founded in 1865 to give the newly emancipated freedmen an opportunity for education of the mind in an ethical, religious environment. A historically black university, Virginia Union University embraces the uniqueness and contributions of the African Diaspora, celebrating the value of cultural and intellectual diversity. Mr. Maitland will also be establishing an endowed scholarship to support students of the Fine Arts, which will be named in honor of his mother, The Carolyn P. Maitland Endowed Scholarship Fund. Carolyn P. Maitland was an art teacher for the New York City school system for over 25 years and received her BFA from Syracuse University in the 1950s. Despite limited opportunities available for artistic expression during that era, Carolyn pursued her passion for art with the encouragement of her husband and Tracy's father, Dr. Leo C. Maitland. Dr. Maitland, a fellow avid admirer and collector of the arts, was also on the medical team that operated on Dr. Martin Luther King Jr. at Harlem Hospital when he was stabbed in New York in 1958. Carolyn earned her Doctorate of African American Art Education at Columbia's Teachers College while continuing to teach and inspire her students.

Commenting on the honor, Mr. Maitland said, "I am deeply honored to receive this recognition from Virginia Union University. As a firm believer in the power of education, I am committed to supporting students in their pursuit of knowledge and creativity. The Carolyn P. Maitland Endowed Scholarship Fund will help to ensure that every student has the opportunity to explore their voice and visions through the fine arts. I hope that this scholarship will inspire and support the next generation of artists and educators."

He is a member of the Wildlife Conservation Society (WCS) Council, where he primarily focuses on legislative affairs, and previously served on the Boards of the ASPCA, Columbia Board of Visitors, the Apollo Theater, the Managed Funds Association (MFA), and the Studio Museum of Harlem. Tracy has also worked closely with Icon Mann, an organization committed to positively transforming the dialogue and imaging of African Americans through content and community engagement. He is a graduate of Columbia College at Columbia University.
